However, the citizen-driven approach, in general, refers to human network orientation filled with various aspirations and needs of human beings as well as social capital that enhance trust, concern for one's associates, and cooperation. In several fields of research and public policymaking, the concept of social capital and social inclusion are regarded as essential for governance. Discussing city materializing the concept of a citizen-driven approach for smart cities will contribute towards the continuous enhancement of the smartness of the communities in Asian regions.
